***Please Read and Print for Reference***

The Ida Christmas Mall is a beautiful white French Window tent with five furnaces and two double doors for entry located in the Ida Farmers Co-Op parking lot.

**EXHIBITORS LIABILITY:** Exhibitors accept full responsibility for any loss, injury, or damage to persons or private property that may be sustained while on said property. Christmas in Ida Festival will assume **no** responsibility whatsoever for any property in the exhibit areas, on the premises, or in any of the parking areas. Open flames are strictly prohibited. No caustic chemicals allowed in the tent.

- 1) ***Vendors must supply their own tables and chairs.***
- 2) Vendor booth space lines are not to be moved. Booth space 10X10 ft.
- 3) Crafter displays may not exceed vendor space lines.
- 4) Please be considerate of your fellow crafters/vendors that are next to you. Make sure there is a passage that can be used to get in and out of the booth space.
- 5) During and after the show, please use trash containers for all waste.
- 6) Christmas in Ida reserves the right to site final placement booth space at the craft and vendor shows.
- 7) An agreement will not be approved unless full payment is submitted with signed agreement.
- 8) Disruptive or non-compliant vendor or crafter will be directed to leave the tent and grounds.
- 9) Christmas in Ida reserves the right to final placement of crafters.
- 10) Vendors or crafters shall not leave before 7:00pm.
- 11) There will be security on Friday night after closing until 6am.
- 12) **Electricity** - Limited electricity will be available.
  - If you desire electricity, please request electricity on your agreement form. If using festival electricity, bring a heavy duty 12–14-gauge extension cord and a power strip/surge protector with an internal circuit breaker. Electricity is for lights only.
  - Heaters, presses, cooking appliances or high electrical use items will not be permitted unless vendor provides their own generator located outside of tent with exhaust away from tent.
  - Use of your own generator is permitted outside of the tent with exhaust away from tent.
  - Failure to comply with electrical rules will result in removal from show.
- 13) Confirmation will be sent to you upon acceptance by email or U S Postal Service. Please make a copy of your application for your records.
- 14) **Set-up Times:**

Friday	3:00pm - 5:00pm
Saturday	8:30am - 10:00am
- 15) **Show Times:**

Friday	5:00pm – 9:00pm
Saturday	10:00am - 9:00pm

**16) Take-down Time:**

Saturday after 7:00pm – You will not be able to load or leave town until after the 7:00pm Parade of Lights.

**17) Parking is accessible on the back side of the tent, behind the Ida Farmers Co-Op office by entering from Mill St. or across the street in a large parking lot by the water tower accessible from VanAkin St. Do not block the space between the tent and buildings.**
