- 1) Exhibitors accept full responsibility for any loss, injury, or damage to private property that may be sustained while on said property. Christmas in Ida Festival will assume **no** responsibility whatsoever for any property in the exhibit areas, on the premises, or in any of the parking areas.
- 2) Christmas in Ida reserves the right for final booth placement.
- 3) Vendor booth space lines are not to be moved. Booth space 10X10 ft.
- 4) Crafter displays may not exceed vendor space lines.
- 5) Please be considerate of your fellow vendor that is next to you. ~~Make~~ Make sure there is a passage between you and your neighbors booth space.
- 6) Vendors must supply their own tables and chairs.
- 7) Open flames are strictly prohibited.
- 8) Caustic chemicals are strictly prohibited.
- 9) During and after the show, please use trash containers for all waste.
- 10) Disruptive or non-compliant vendors will be directed to leave the tent and grounds.
- 11) An application shall not be approved until full payment and signed agreement is submitted.
- 12) Vendors shall not leave before 7:00pm on Saturday.
- 13) There will be security on Friday night until 6:00am
- 14) Electricity – Limited Electricity shall be provided.
 - Please request electricity on application
 - Electricity is limited to lights only.
 - The vendor shall provide 12–14-gauge extension cord and power strip with surge protection.
 - Heaters, presses cooking appliances, or high electric use is prohibited.
 - Use of your own generator is allowed. Generator must be outside of tent with exhaust away from tent.
 - Failure to comply with electrical policy will result in the removal from tent.
